



2017 Schedule of Fees

Kormilda College is a unique co-educational and independent IB World School in the Christian tradition, catering for students from Early Learning to Year 12. The fees below have been determined by the College's Board of Directors and apply from 1 January 2017.

Early Learning Centre

\$440 per week or \$89 per day or part thereof, plus a one-off non-refundable enrolment fee of \$150 per child.

Primary, Middle & Senior School

A one-off non-refundable fee of \$150 per student (other than those moving up from the Early Learning Centre) shall be paid to confirm the acceptance of a position at Kormilda College. There is no enrolment application fee.

Discounts

A discount of \$250 per student is given to families who pay their total annual school fees in full by the end of Week 4 of Term 1, 24 February 2017.

For members of the same family, the following sibling discounts apply to the tuition fees.

Sibling	Discount
Second child	25%
Third child	50%
Fourth and subsequent children	75%

Where more than one discount or concession applies, only the greater is applicable. This includes sibling discounts, staff discounts and scholarships. Discounts do not apply to Early Learning Centre fees.

Capital Levy

An annual Capital Levy of \$330 per student is payable by the due date of Term 1. Families are encouraged to make additional contributions by way of tax-deductible donations to the Kormilda College Building Fund or Kormilda College Boarding Program Fund.

Boarding Fees

Boarding facilities are available for students in Years 7 to 12. The figures quoted below include both the Day School fees and charges (tuition, curriculum and capital) and Boarding fees.
